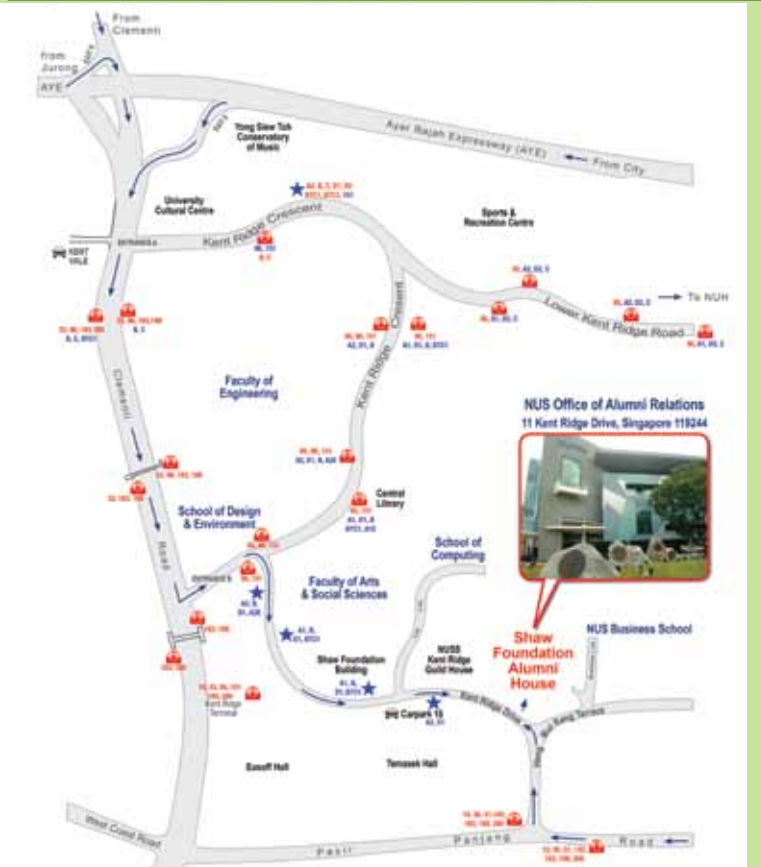
Refund Policy:

VISA AND ENTRY REQUIREMENTS FOR FOREIGNERS

All visitors to Singapore must meet the following entry requirements:

- Valid travel document (minimum validity of 6 months at the time of departure)
- Confirmed onward or return tickets (if applicable)
- Entry facilities, including visas, to the next destination;
- Sufficient funds to maintain themselves during their stay in Singapore; and,

- [Yellow Fever Vaccinations \(if applicable\)](#)

Visitors are advised to check their passports for the arrival endorsement and take note of the number of days of stay given before leaving the checkpoint.

There are no required vaccinations, except for a yellow fever vaccination for those who have, in the previous six days, been in or passed through any of the 42 countries listed on the Immigrations & Checkpoints Authority's website as being endemic for yellow fever (<https://www.ica.gov.sg/page.aspx?pageid=95#yellowfever>)
